## Wills, probate and intestacies

### What information can the researcher find in records of wills?

Wills can be an invaluable resource for family historians, often containing information that may be difficult to access elsewhere, such as the names of married daughters where marriages occurred outside the dates covered by BDM indexes. A copy of the death certificate may be included, along with details of the deceased's assets, occupation and the names and addresses of children and grandchildren.

Things to bear in mind when researching wills:

**Probate:** A deceased person's estate is usually administered by the executor named in the will or appointed by the Supreme Court. Only approximately 5% -10% of all wills go to probate, which is the formal granting of authority by the Supreme Court to an executor to administer the terms of a will. In general probate is only sought when a bank or other institution requires formal proof of the executor's right to administer the will. If there is no requirement for probate, no copy of the will needs to be kept. However, copies of individual wills may sometimes be found in private hands or amongst the records of individual solicitors or executors.

**Intestacies:** Public Curator's files include wills where the Public Curator (now the Public Trustee) was appointed executor (elections) as well as estates for which there was no will and which were administered by the Public Curator (orders). Thus, some wills that did not go to probate may be located with intestacies files.

#### Queensland

**Queensland State Archives** [Search the indexes < Courts]

- **Wills 1857-1940 (digitised):** Indexes wills compiled from Supreme Court files for all districts to 1900 with separate index to wills for the Southern District (Brisbane) for 1900-1940. It includes some wills for people who died outside Queensland. It does not include Public Curator intestacy files.
- **Equity Files Index 1857-1899:** An online index to Supreme Court Equity files. The files include surname and given name of all people connected with a case including deceased, interstate and overseas residents but excluding long lists of creditors and shareholders of companies. The date is the date the case was first filed in the Supreme Court.
- **Instruments of Renunciation Index 1915-1983:** Indexes Instruments of Renunciation lodged by executors who were no longer willing to administer a will. The records include name, address and occupation of the deceased, date of death (and place if other than the deceased's address), date of will, name and address of executor, relationship to the deceased and date of renunciation.
- **Trustees Files Index 1889-1929:** The files all relate to trusts set up under the terms of a will. They often cover several years with some files pre-dating the Trustee Act of 1889. The records may include information on the deceased's land ownership, children or other relatives, and employees.

For wills the most effective search is by name of the deceased or the executor. Check the website's *Guide to searching* (<https://www.courts.qld.gov.au/services/search-for-a-court-file/search-civil-files-ecourts/guide-to-searching>) for additional search options for the Brisbane area.

The index is updated in real time. Files commenced before the listed dates in these districts are included only if there has been some activity on the file since the index' commencement date.

**Victoria**

**Public Record Office Victoria** (PROV) holds wills, probate and administration files from 1841-2019. Wills and probate records need to be searched separately. Records between 1841 and 1925 can be viewed online. Records after this time can be viewed in the PROV Reading Room or you can request and purchase a copy to be emailed or posted. Files up to 1947 are available at State Records Office on microfilm for viewing. For any records less than 75 years old approval from the Supreme Court is needed before viewing. Application forms are available from the State Records Office.

### **New Zealand, Archives New Zealand, Probate Records, 1843-1998**

Available from The Church of Jesus Christ of Latter-Day Saints 'FamilySearch' website. To search you do need to register but it is free to view. The records were created by various courts throughout New Zealand. The index contains entries up to 1998 when all images have been captured, but the images for probates issued during the past 50 years are unavailable for viewing due to New Zealand privacy laws. The original records are held at the Archives New Zealand offices situated in Auckland, Wellington, Christchurch and Dunedin.

## What about wills in Britain and Ireland?
